EXCITING CHANGES WITHIN THE LEADERSHIP DEVELOPMENT TEAM

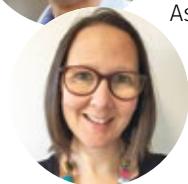
Team leader of the Leadership Development team, James Lawrence, is taking on a new role of Leadership Champion at CPAS. In this

THE GUIDE: NAVIGATING LEADERSHIP AS A FOCAL MINISTER

Increasingly churches and congregations are led by a diverse range of people. Sometimes called Focal Ministers or Focal Leaders, they might lead a Fresh Expression, congregation, church plant or church. Some of these leaders may not be ordained, may be unpaid, and may have received little leadership training for their role. The Guide provides on-the-job-training in a simple, creative and accessible way. 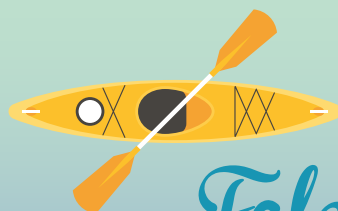

Stories from Danehill Taster Venture



Interview with Danehill Venture leader Paul Peterson, pictured, on what God has been doing this summer.



A new approach in Danehill, East Sussex, is drawing young people to Venture holidays who would never otherwise attend – and their lives are being changed by Jesus.

Step into the immaculate grounds of Cumnor House School in the summer months, and you'll find dozens of young people exploring faith. Danehill Venture's three week-long bespoke holidays happen here, where teenagers can encounter Jesus, grow in faith and develop as leaders.

It's an incredible, life-changing programme overseen by associate minister the Rev Paul Peterson, who himself came to faith on a Venture holiday 40 years ago. Recently however, Paul realised some young people were missing out.

'What about the teenagers who are anxious about being away from home for a whole week? Or the families struggling to afford a seven-night residential?' said Paul. 'We saw an opportunity to do something new to reach more young people.'

So, several years ago, in addition to the other Danehill Ventures, the team launched 'Danehill Taster' – a four-night holiday for 12 to 15-year-olds. The days are packed with sports and craft activities, the mornings and evenings include faith talks, worship, prayer and Bible study.

Most young people attending the taster are first-timers on a Venture, and are generally from more diverse backgrounds than the usual crowd. This year, the 45-strong group included 25 from groups in South London.

'We had a large group of kids from a more deprived area, who were quite edgy at first. They came with a bit of attitude,' said Paul, 'but to see them soften and open up to God as the week went on was beautiful. They let their guard down, joined in the activities, and really engaged.



Now we hope they'll go back to their home church and really grow in faith there.'

Already, the impact of Danehill Taster is evident. One parent said, 'When my 12-year-old came home singing the Christian song Way Maker, it brought a tear to my eye and a smile to my face.'

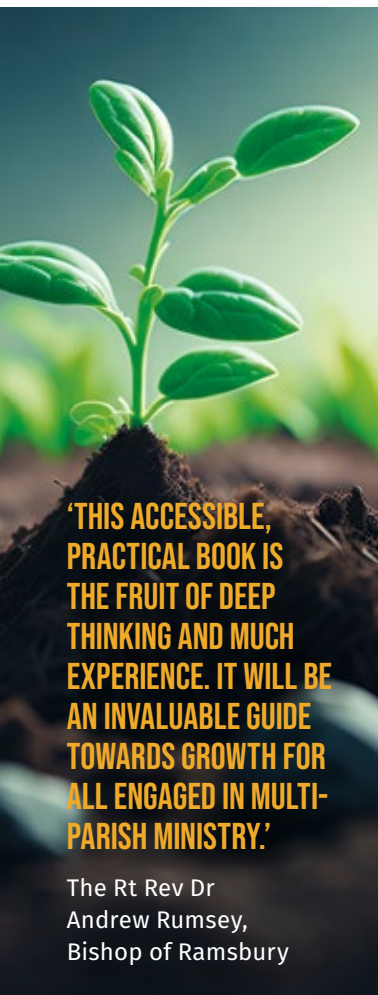
And it's this – seeing the Lord touch young people's lives – that draws Paul back, year after year. 'I went on my first Venture holiday in Limsfield in 1983, came to faith in Christ, and have been involved ever since,' he said. 'Every year I ask God, is this still right for me? And every year I'm totally convinced it is. I'm 56 now and my enthusiasm hasn't dimmed.'

Paul, who works part-time at Christ Church Downend in Bristol, and part-time for the Limsfield Trust, which supports Danehill Ventures, added, 'I 100% believe in the value of residential youth ministry. It can provide key moments of encountering God for young people. It's a joy to see God change lives through Ventures, and to see teams of people working together for the gospel cause.'

Paul's message to CPAS supporters is this, 'Please keep praying. Keep giving. We long to enable more young people to meet with Jesus at Ventures like Danehill. and to see many of them come back as leaders in the years to come. Thank you.'

The Thrive Collection

Pam Macnaughton knows all about the challenges that MPBs face. Pam is a former CPAS Leadership Specialist, now working for the Church of England Vision and Strategy team, and as an ordained pioneer minister for a group of churches in Derbyshire. As an innovative joint project between CPAS and Church House Publishing, Pam has spear-headed Thrive: a proven and targeted collection of resources developed specifically for MPBs, to help them release their potential.

In the book, *Thrive: Helping Your Multi-Parish Benefice to Grow*, Pam recalls:

'There was a palpable sense of relief in the room, growing as time progressed, with, "Oh, it's not just us", comments. What was going on?

'Ten years ago, I started running learning-and-action communities for lay and ordained leaders and

members in MPBs. Around six teams from a diocese journeyed together for two or three years. A sense of relief occurred without fail every first session, when people realised they were not the only ones struggling with the joys and complexities of living and working in a group of churches, sharing clergy and lay leaders.'

Pam's conviction was that working together actually increased opportunities for growth and new life, both within and outside church communities. So, *Thrive* began. Partly derived from material created with the Arthur Rank Centre and LEAD Academy, CPAS Thrive Communities have run in a number of dioceses, in rural, suburban and urban settings. But, do they work?

As they journeyed together, the Thrive communities saw relief turning to hope,

new vision and positive action. The MPB teams prayed for each other, learned together, shared plans, started initiatives, deepened prayer lives and encouraged new disciples. They grew new leaders, launched into youth work, and increased their confidence in sharing their faith.

Through the combination of regular input and encouragement, practical planning, lots of prayer and hard work, I saw MPBs transformed for the better.

THE THRIVE COLLECTION – NOT JUST FOR LEADERS

Through a theologically underpinned and carefully planned learning-and-action process, and based on church growth research, Thrive will enable MPBs to consider: prayer, the stories of our churches, developing leaders, growing disciples, sharing faith and vision for the future.

Living in Love and Faith

'Living in Love and Faith, and Prayers of Love and Faith, have been rolling through the Church of England and synodical processes. Our priority at CPAS has been to figure out how we engage with churches and their leaders in order to support their conversations, represent their views, underpin them with prayer and maintain a focus on mission and evangelism. I thought supporters would like to hear how we have done those things.'

Firstly, we decided to ask our patronage clergy where they are at in the conversations, and what support they would appreciate from CPAS. The survey was well received. Out of 520 current serving incumbents, 49% responded to our in-depth survey, which demonstrated something of how much it is at the top of their minds. Our findings showed us that:

1 All our clergy are committed to leading churches that are open to everyone, whatever their views on the prayers and associated issues.

2 75% of our clergy believe that some proposed prayers are contrary to the historic teaching of the Church.

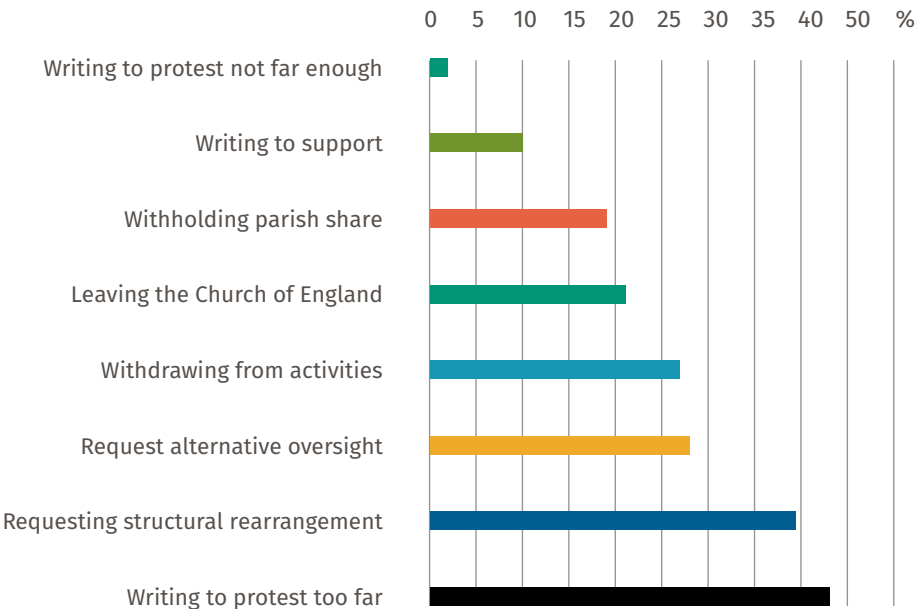
3 83% would be unable to use some or all of the prayers.

4 Not surprisingly, many of them are engaging in 'principled protest', including discussion with their senior clergy about steps they might take if the prayers are agreed.

5 It is important to add that there are a significant minority of clergy in parishes where we have patronage interest that are very positive about the prayers,

and are therefore supportive of the direction of travel.

Secondly, we followed this up with a series of online consultations that CPAS CEO, Jon Scamman, and I facilitated in order to improve the depth of our enquiry and collate resources that are currently being used and promoted on both sides of the current debate. These live conversations received significant levels of appreciation, particularly as a place of engagement for clergy that feel alone in their

thoughts about it. One of the things that we heard often was that their voices weren’t finding places of expression, and so in light of that we agreed to the next step.

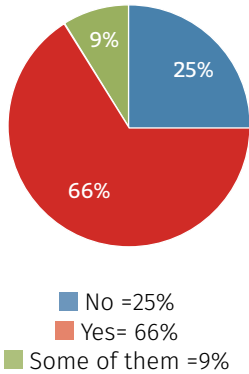
Thirdly, we fed back to the College of Bishops/Synod working groups a summary of our findings, being careful to offer them not so much as a campaign, but as a way of expressing the breadth of voices and strength of feelings from the ground. In order to separate the internal views of CPAS from the voices of those

we were representing, we placed a short statement on our website for those who wanted to know our position.

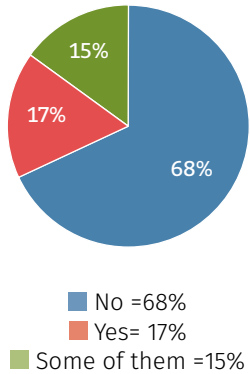
Fourthly, we have helped facilitate a number of PCC discussions about LLF in order to take the heat off the clergy who are both chairs of the discussion and the ones who implement the decisions made.

Fifthly, staff members have made themselves available for a range of one-to-one conversations.

Finally, we are continuing to contact our clergy on a daily basis to ask what we can pray for and, not surprisingly, LLF is a frequent topic of conversation.

WHERE DO WE GO FROM HERE?

We have reworked our material for churches on How to have Difficult Conversations, in order to assist leaders to engage well with these topics, particularly those leading in communities where different views are held.

We continue to engage with PCCs that are wanting to move forward and beyond this debate. As

we prayerfully await the decisions of General Synod, we are conscious that our primary calling as an Anglican evangelical mission agency is to support the mission of the local church in all its various forms, and we are committed to doing that through the coming decades.

In the many one-to-one discussions taking place, we have found that some churches who have settled their thoughts on this topic are moving on to discover a fresh level of engagement with the gospel in their community. While the foundation of so much in our world is shaking through the

movement of environmental, political or sociological tectonic plates, the sure foundation of Jesus Christ is as ever the good news for an ever-changing world.

Listening to Your Voice

Thank you to all of our supporters who took the time to complete our recent supporter survey. We have come to know many of you over the years that you have supported CPAS. We wanted to understand more about you and how CPAS can journey with you in the future.

Some highlights of what you told us:

Over the last two years, 87% of our supporters have prayed for us, 16% have either sent a child on one of our holidays or volunteered on one and 48% have made a regular donation to CPAS.

94% of our supporters who responded told us they receive information by post, 56% by email and 28% by our websites.

91% of our supporters think we explain our big goals well, 77% feel we say 'thank you' very well, 74% are inspired to pray and 73% think that the stories we feature are told well through words.
